THE FACTS

WHAT, WHERE & WHEN

Gori Julian & Associates, P.C., in partnership with Global Brew Tap House, is hosting Oktoberfest in City Park near downtown Edwardsville for the fourth year in a row. With this event, which attracts several thousand beer enthusiasts, the hosts are continuing their commitment to raise funds to help support the education and research of the Mesothelioma Applied Research Foundation (MARF).

In addition to raising awareness about the MARF, the event includes beer carts featuring German and craft-style beers, food from local restaurants such as 222 Artisan Bakery and 1818 Chophouse, a raffle for a grand prize trip for two to Germany, live music, games and other fun attractions.

WHY

MARF is the only non-profit organization dedicated to ending mesothelioma and the suffering caused by it by funding research, providing education and support for patients and their families, and by advocating for federal funding of mesothelioma research.

Approximately 3,000 or more Americans develop malignant tumors associated with mesothelioma each year. Exposure to this disease is in most cases involuntary, happening at work or indirectly at home. In basic terms, Mesothelioma is a rare cancer in which cells of the mesothelioma (a membrane that covers and protects most of the internal organs of the body) become abnormal and malignant. The known cause of mesothelioma in the United States is asbestos. Most people who develop mesothelioma have worked in jobs where they inhaled or ingested asbestos fibers, or were exposed to airborne asbestos dust and fibers in other ways.
